Articles of the Association

§ 1 Name and location

The association bears the name

"Hilfe für Afrika - Hilden".

It shall be registered in the register and then carries the additional

"e.V."

The seat of the association is

Hilden

§ 2 Fiscal - Business year

Fiscal year is the calendar year.

§ 3 Purpose of the Association

1. The association pursues exclusively and directly charitable purposes within the meaning of the "tax-privileged purposes" of the German Tax Code § 52 paragraph 2 of the AO.

The purpose of the association

- a. promoting international attitude, tolerance in all fields of culture and international understanding;
- b. the promotion of development cooperation;
- 2. The statutory purpose of the association is particularly through the planning, execution and collaboration of information, music and dance performances, lectures, provision of brochures, slide presentations, workshops, distribution of benefits in kind, food, charitable care and assistance, consultations, seminars, lectures, lecture series, building of schools, kindergarten, construction of fountains, roads and streets, procurement and provision of medical supplies and medicines, and physical resources of all types (e.g. clothing, shoes, household objects, etc.), collection of money and in kind, holding of consultations, assistance with administrative procedures,

In particular, should

a. promoting international attitude, tolerance in all areas of culture and international understanding as to performed by information events, lectures, workshops, seminars, slide shows, music and dance performances, exhibitions, etc.;

b. the promotion of development cooperation is as through information sessions, lectures, workshops, seminars and slide shows, planning, supervision and construction of fountains, schools, kindergarten, roads etc.

§ 4 Selflessly activity

The Association is selflessly active; it does not pursue its own economic purposes. The offices in the organs of the Association are volunteers.

§ 5 Allowances for the activities in the association

Basically, the work in the association and work of the bodies are out of honorary capacity. But In the context of the budgetary possibilities there is the possibility of a compensation expense pursuant to § 3 No. 26 a (note: this is the volunteer package) or for consideration exercise based on a service contract.

The decision is made by the Executive Board. The Executive Board also applies to contract terms and contract content, and for a possible contract termination.

The Executive Board of the Association and members, who are acting under the authority of the Executive Board, also have a claim for reimbursement of expenses pursuant to § 670 BGB driving costs, travel expenses, postage, telephone and other expenses they incur for the association's work will be reimbursed against proof, provided that the costs claimed within a period of six weeks, the documents or statements of expenditure (eg telephone charges, travel expenses, etc.) in good present condition.

The Executive Board may fix by resolution under the tax law limits the possibilities of the amount of reimbursement of expenses pursuant to § 670 BGB.

§ 6 Use of Funds

Funds may only be used for statutory purposes. The members receive no benefits from the association.

The association is liable only to his association's assets and any existing contract with a third party insurance.

A secondary liability and funding obligations of members are excluded.

§ 7 Prohibition of benefits

No person may benefit from expenditures that are foreign to the purpose of the Association, or from disproportionately high remuneration.

§ 8 Acquisition of membership

Members of the Association can be natural persons or legal entities.

The application for admission is made in writing by the associations own form and submit one original.

The Executive Board decides on the request.

Against the rejection that requires no justification, is said to be the candidate to appeal to the General Assembly, which will decide finally.

A honorary members may be appointed on the recommendation of the Executive Board or ¾ of General Assembly by decision of the General Assembly by a majority of ¾ of the lifetime. The honorary members have the rights of a member and shall be exempt from the obligation of the membership fee to contribute.

§ 9 Termination of Membership

Membership is terminated by resignation, expulsion, death or dissolution of the legal person.

The withdrawal is made by written notice to a representation member of the Executive Board. The written notice must be explained by a period of one month each at the end of the fiscal year to the Executive Board.

Exclusion can be made only for good cause. Important reasons are a particular aims of the Association injurious behavior, breach of statutory duty or arrears of at least one year. The Executive Board decides on the exclusion. Against the exclusion of a member is to appeal to the General Assembly, which shall be addressed in writing to the Executive Board within one month. The General Assembly makes decisions at the club permanently. The member will review the measure through recourse to the ordinary courts reserved. The recourse to ordinary courts shall have suspense effect to the legal effect of the judgment.

§ 10 Membership fee and Entrance fee

Of the members will an entrance fee upon entering the association and an annual dues are collected. The amount of the entrance fee and the annual membership fee and the maturity determines the general meeting.

§ 11 Bodies of the Association

Bodies of the Association are

§ 12 General Meeting

The General Assembly is the supreme body of the Association. The General Assembly tasks include the selection and deselecting of the Executive Board, Discharge of the Executive Board, Receiving the reports of the Executive Board, choosing the treasurers, establishment of an entrance fee, membership fees and their due dates, resolution on the amendment of the Articles of Association, resolution on the dissolution of the Association, decision on the admission and expulsion of members in appeal cases and other objects, insofar as these arise from the constitution or by law.

In the second quarter of each fiscal year an ordinary general meeting takes place.

The Executive Board is to convene an extraordinary general meeting be obliged if requested at least one-third of the members in writing, stating the reasons.

The General Assembly is convened by the Executive Board by giving notice of one month in writing, stating the agenda.

The period begins with the day following the dispatch of the invitation letter. The invitation letter is as the members received if it was sent to the last known address of the association.

Delivery to a specified member of the e-mail address is alternatively as a fulfillment instead.

The agenda shall be supplemented, if a member requests in writing no later than one week before the scheduled date. The supplement shall be published at the beginning of the meeting.

Applications of the deselecting of the Executive Board, to amend the Articles of Association and the resolution of the Association that are not already submitted to the members with the invitation of the members at the member meeting can only be decided at the next members meeting.

The General Assembly shall constitute a quorum regardless of the number of members present.

The General Assembly is chaired by an Executive Board member.

At the beginning of the member meeting is to choose a secretary.

Each member has one vote. Voting rights may be exercised in person or in representation of a member under a written power of attorney.

In voting and elections, the simple majority of votes decide. Resolutions and elections equality of votes is deemed rejection.

Voting and elections will be completed by acclamation.

A member may request the implementation of secret ballot. With the consent of half of the members present, the election must be conducted in secret.

Amendments to the Articles of the Association and the dissolution of the Association can only be decided by a majority of 3/4 of the members.

To change the association's purpose, the consent of all members is required.

Abstentions and invalid votes are not counted.

The decisions of the General Assembly a report shall be prepared, which shall be signed by the chairman and the secretary.

§ 13 Executive Board

The Management Executive Board within the meaning of § 26 BGB consists of the / of the 1st Chairman. She / He represent the association in and out of court.

The Executive Board is elected by the Assembly for a period of five years dialed.

Executive Board members may only be members of the association.

Re-election is permitted.

The Executive Board may also take other offices and function in the association as well as at the general assembly.

The Executive Board remains in office until a new Executive Board is elected.

Upon termination of membership in the association and the position of CEO ends.

The Executive Board is responsible for legal transactions that serve the interests of the association or as a defense or which are necessary to fulfill the purposes of the association exempt from the restrictions of § 181 BGB.

§ 14 Cash audit

The General Assembly elects auditors for a period of five years. Re-election is permitted.

§ 15 Execution of the Articles for the Association and Rules of Procedure

The Executive Board may adopt regulations as needed to implement the Articles of the Association.

The Executive Board may adopt rules of procedure as required. The work and competence deferred of the organs may thus be regulated by the statute beyond in rules of procedure. The rules of procedure are not part of the Articles of Association.

§ 16 Liability

The association is not liable to its members for damages and losses that arise on the occasion of meetings, events and other exercise of association and / or club right on the insurance also.

The liability of the association to members and third parties in accordance with § 31 of the BGB is guaranteed.

The association is liable only to his association's assets. A secondary liability of the members is excluded.

§ 17 Dissolution of the Association

With the dissolution of the association or loss of tax-privileged purposes the assets of the organization will go to the German Red Cross - German Red Cross local branch Hilden e.V. Hofstraße 64, 40723 Hilden, that has be used directly and exclusively for charitable, benevolent or religious purposes.

§ 18 Entry into force

The Articles of the Association shall come into force upon registration in the register of the local court Langenfeld.
